### Introducing Fall-Free Fridays

According to the National Council on Aging, falls remain a leading cause of injury for people aged 65 and older. Falls threaten older adults' safety and independence and generate enormous economic and personal costs. The good news is that they are preventable and there are proven steps people can take to reduce their risk.



Historically, the Area Agency on Aging District 7 (AAA7) and the Shawnee State University Occupational Therapy (OT) Program have worked together to provide falls prevention education to the community through the AAA7's "Matter of Balance" falls prevention program. Students have become trained in the program and help to facilitate the course to interested community members in the district as a part of their class requirements. At the present time, due to social distancing recommendations and health protocols in place during the current pandemic, in-person wellness classes with the AAA7 have not been able to be held; therefore, not making the opportunity possible for OT students to participate in providing education to the community.

Thankfully, a solution was developed to provide this education through a virtual format on the Area Agency on Aging District 7's Facebook page. In September, the AAA7 began featuring "Fall-Free Fridays", a live, weekly interview with two Shawnee State University OT graduate students who provide community education on a falls-related topic and information about falls, risk factors, and helpful prevention tips. The AAA7 also shares this information on their website at www.aaa7.org and also offers a "Fall-Free Friday Fact" weekly on the AAA7 Facebook page and website.

### It's Medicare Open Enrollment Time

**Open Enrollment is October 15th through December 7th.** This is the time of the year when changes can be made in the plans and providers you've chosen for your Medicare Part D prescription drug coverage and/or Medicare Advantage option. If you wish to make changes, you can only do so between this time. Open enrollment is also a good time to run drug comparisons to make sure the Medicare Part D plan you are on is still your best option as Medicare Part D plans do change from year to year.



Individuals who receive the Low Income Subsidy (LIS) can change their plans anytime of the year. Even if you are receiving help through LIS, it is a good idea to check your plans to make sure all of your medications will be covered on your current plan for 2021.

The AAA7 is a local resource you can utilize for assistance with the open enrollment process and can be reached by calling 1-800-582-7277.

To be eligible for Medicare health insurance plans, you must be at least 65, or be on Social Security disability for two years, and be a US resident or legal citizen for at least five years.

Original Medicare, sometimes referred to as Part A and Part B, helps with hospital, doctor and outpatient services. More than likely, a Medicare supplement is needed in order to cover the costs not covered by Parts A and Part B. Medicare Advantage, or Part C, combines Parts A, B and D in to one plan. During Open Enrollment, beneficiaries have the opportunity to make changes to these plans that provide better support for their health and well-being. It's a time to change what doesn't work and keep what does.

## COVID-19 Update

2020 has certainly been a year none of us will ever forget. It's been a year of learning and adjustment, but through the entire process, our Agency has continued to provide the essential services that so many of our consumers depend on.

Recently, our state association, the Ohio Association of Area Agencies on Aging (o4a), distributed a survey to Ohio Area Agencies on Aging (AAA) and published a special report with the results. Highlighted was the response of AAAs to the needs of our communities and what challenges lie ahead as we all grapple with the long-term effects of the coronavirus. The responses from the survey revealed that the needs for older adults are growing and changing, with more emphasis on how to live with the reality of the virus safely, but most importantly, in a way that does not disengage older adults from the efforts to move us all forward with the new "normal."

The AAA7 sent statistics for part of the o4a report. Below are numbers from the AAA7 for the timeframe March - September 2020.

- People Receiving Home-Delivered Meals 3,402
- Home-Delivered Meals Provided 564,634
- Grab and Go Meals Provided 24,031
- Wellness Kits to Senior Apartments 3,400
- PPE/Educational Kits Presented to AAA7 Independent Providers 390
- Telephone Reassurance/Check-In Calls 623
- Information and Assistance Calls 3,875
- Caregivers Who Received Support 3,114

As a result of the pandemic, our Agency has developed some creative ways to reach out to our consumers and the community. These have included: Porch Talk Telephone Reassurance Program, Wellness Tip of the Week, Telephone Caregiver Support, Telephone Wellness Classes, Fall-Free Fridays, and Telephone Volunteer Ombudsmen opportunities. We have also delivered PPE to our providers and wellness kits to senior apartment complexes in our district thanks to federal CARES Act dollars that the Ohio Department of Aging directed through our Agency as the channel for COVID-specific supplies for our local providers.

As always, the AAA7 has and continues to operate as essential employees, serving our vulnerable populations. We are proud to be able to continue providing needed services to our community now and beyond.
