AAA7 Applauds Governor's Action to End Wait for Senior Services

Advocates for Ohio's older adults, including your local Area Agency on Aging District 7, Inc. (AAA7), are very appreciative to Governor Ted Strickland with the recent announcement of his order to end the waiting list for PASSPORT and other in-home and community services. With this action, 592 older adults on the waiting list across the state, including 52 in our 10-county district, are now able to access the long-term care they need and deserve.

PASSPORT (Pre-Admission Screening System Providing Options and Resources Today) is a Medicaid waiver program operated through the Ohio Department of Aging that provides medical care to qualifying seniors in home and community settings. Locally, PASSPORT is coordinated and administered by the AAA7 and is made possible by funds through the Ohio Department of Aging (ODA). Waiting lists were implemented by the ODA for these services in order to balance their budget for fiscal years 2010-2011.

"The AAA7, along with other area agencies across the state, is pleased that Governor Strickland called the order to eliminate this waiting list so that older Ohioans can receive the care they need and deserve without delay," commented Pamela K. Matura, Executive Director of the AAA7.

Services provided through PASSPORT include personal care, homemaking, home-delivered meals, medical emergency response systems, medical transportation and adult day care, in addition to home medical equipment and supplies. Those eligible for PASSPORT services include individuals 60 years of age or older who are Medicaid-eligible and live in a private residence where

they can be safely supported. Individuals who meet these requirements and need hands-on help with daily activities such as bathing, dressing and meals to remain at home could be eligible for PASSPORT services.

AAA7 Staff Present at National Meeting

Staff from your local Area Agency on Aging District 7, Inc. (AAA7), was recently invited to make a presentation at the 2010 Community Living Program and Aging Disability Resource Center National Meeting, sponsored by the Federal Administration on Aging, Department of Veterans Affairs, and Centers for Medicare and Medicaid Services. The meeting was held in Alexandria, Va., February 22 through 24, 2010, with over 350 professionals from across the nation in attendance.

Vicky Abdella, RN, AAA7 Director of Community Services, and Rita Pauley, Planning and Program Development Manager, presented information on the AAA7's non-Medicaid community living program, *My Care, My Way*. Also in attendance from the AAA7 were Case Managers Donna Hurt and Merritt Sessor.

My Care, My Way is a non-Medicaid consumer-directed program that allows adults age 60 and older the most flexibility in choosing the support services they receive in their home. Consumers in the program have the opportunity to evaluate and choose who they would like to assist them in meeting their needs. Instead of the Agency managing the in-home services, with My Care, My Way, the consumer takes that responsibility, essentially becoming the "employer" of the providers.

In Ohio, *My Care, My Way* began development in late 2008 through a Nursing Home Diversion grant received by the Ohio Department of Aging from the Federal Administration on Aging. AAA7 was selected to serve as the only site in Ohio to demonstrate the activities within the project in order to guide development of similar programs throughout the state. Since the pilot was launched, 50 older adults are now participating throughout AAA7's ten-county district.

My Care, My Way requires the AAA7 to capture consumer eligibility, assessment, satisfaction and outcomes, as well as program costs and the direct savings created by assisting non-Medicaid consumers in a self-directed

program. Fortunately for residents in southern Ohio, the AAA7 has developed a process utilizing a software system already established at the Agency to capture the data to support success and growth of the program. It was this process and success that was a highlight of the AAA7's presentation at the national meeting.

AAA7's presence at the conference was most impressive as few states across the nation have been successful in totally utilizing a software system to capture all data that is needed for consumer success and program evaluation in their community living programs. The software the AAA7 utilizes to support this endeavor is the Social Assistance Management System developed by Harmony Information System, Inc.

Having the opportunity to share our successes with other programs and projects throughout the country was quite humbling for us," commented Abdella. "We had many questions and inquiries after our presentation and were quite pleased with the reception we received. Our development of a successful process through *My Care, My Way* has given our staff a sense of pride and ownership that will only enhance the services we provide. I am very proud of the work our Agency does each and every day to support safe and secure independent living for seniors in our region."

Ohio's Home First Bill

On Wednesday, March 24, in one of its last actions before leaving for its Spring Break, the Ohio House of Representatives passed unanimously an amended version of the Home First Bill, House Bill 398 (HB 398). The law would revise waiting list provisions for PASSPORT and Assisted Living services under Ohio's Medicaid waiver program for those individuals who would prefer living at home with some assistance when nursing facility placement is their only option. This "Home First" legislation would extend the current program to older adults leaving hospitals or in abusive and self-neglect situations, as well as those who have depleted their assets in assisted living, or whose physicians have signed that they are at risk of nursing facility placement within 30 days.

A companion bill in the Senate, SB 214, passed out of committee by unanimous vote, but has not been introduced to the full Senate for a vote.

<u>President Signs Healthcare</u> Reform

President Barack Obama signed the law to reform health care, House Resolution (HR) 3590, the Patient Protection and Affordable Care Act, on Tuesday, March 23, 2010. The law will expand Medicaid to cover 16 million more people, reduce Medicare expenditures in the next decade by half a trillion dollars, and establish many demonstration projects to test innovative ways of delivering health care.

A second bill, HR 4872, the Health Care and Education Affordability Reconciliation Act of 2010, completes the overhaul of health care. It contains amendments to healthcare reform legislation that include:

- Changes in the levels of subsidies to help Americans buy health care insurance.
- Increased federal funding to states for Medicaid.
- Expanding the Medicare payroll tax for some higherpaid Americans to make up for a significant revenue drop created by delaying an excise tax until 2018 on highcost health care plans the Senate proposed.
- Clarification of a provision requiring insurers to allow adult children to remain on their parents' insurance policies until their 26th birthday.

The Congressional Budget Office (CBO) issued a preliminary cost estimate for the legislation, which totals \$940 billion over 10 years and reduces federal deficits by \$138 billion during that same time. CBO also estimates that the reconciliation bill would save an additional \$9.9 billion in Medicare payments over the next 10 years by reducing increases for hospitals and rehabilitation facilities.

Of special interest to the aging network in Ohio are these reforms in the bills:

- Ohio's 1.8 million Medicare beneficiaries will receive all recommended preventive services for free and can visit their health care provider for a free annual wellness checkup and personalized prevention plan.
- 325,000 Medicare beneficiaries in Ohio hit the doughnut hole each year. The Medicare Part D doughnut hole will close by 2020. This is the gap in the Medicare prescription-drug benefit in which the Medicare beneficiary continues to pay the insurance premium but receives no help in paying the cost of drugs. In 2010, beneficiaries who fall into the doughnut hole will receive a \$250 rebate.
- Older adults will see a 50 percent cut in the cost of brand name drugs upon entering the donut hole.
- As overpayments to Medicare Advantage plans are reduced, the 74 percent of Ohio's older adults who are not enrolled in these plans will no longer subsidize them through their Medicare premiums.

Social Workers Recognized

March was National Social Work Month with the theme "Social Workers Inspire Community Action".

Most social workers serve individuals and families, providing resources and guidance that support social functioning. Through the Area Agency on Aging District 7, social workers cover a wide range of services to individuals in the Agency's 10-county District.

Social Workers with the AAA7 wear many different hats and take on a variety of roles including advocate, assessor, case manager, consultant, information sharer, and referrer. Social workers conduct these functions for the many programs available through the Agency that provide individuals with assistance to support independent living in their own home.

Social workers recommend and refer these individuals to services like personal care/homemaking, adult day care, assisted living, home repair, transportation, homedelivered meals, and client advocacy in order for them to remain safely and independently as possible in their home. Residents in the District's 10-county area who call the Agency can talk directly with a nurse or social worker who will assist them with information surrounding the programs and services that are available to best serve their needs. Social workers in the Agency assist with this process by serving as a facilitator to assist seniors with these services, determining what is best for their situation while assuring follow-through and follow-up.

"We applaud and salute our social workers throughout our Agency during National Social Work Month in March," stated Pamela K. Matura, Executive Director for the Area Agency on Aging District 7, Inc. "Through their hard work and dedication, seniors in our region have the resources that make it possible for them to live safely and securely in their own homes."

to make a real difference in the lives of others? If so, the Area Agency on Aging District 7, Inc. (AAA7) has an opportunity for you or someone you know who may be interested in helping some of our most vulnerable citizens - nursing home residents.

Looking for an opportunity

Through AAA7's Volunteer Ombudsman Program, these special helpers visit nursing home residents on a regular basis to provide them with a link to the outside world. Through these visits, Volunteer Ombudsmen help to lessen the isolation and loneliness many residents experience. Volunteers also provide an essential voice for residents, providing advocacy and assistance for those who have concerns about their care.

Volunteer Ombudsmen plan their own schedules, are permitted to visit any day of the week, and are provided hands-on training and technical assistance by the AAA7's Ombudsman Program Staff. Volunteers are recognized during an annual event and invited to various AAA7 training programs and conferences at no cost.

Doug McCoard, a Volunteer Ombudsman from Pike County, who volunteers in Scioto County, does feel that he has made a difference for residents of nursing homes who are unable to speak for themselves. "What I like best about my role as a Volunteer Ombudsman is that I have the opportunity to not only speak for residents, but also provide residents with the encouragement and assistance to speak for themselves. It's what keeps me going back every week knowing that I am providing a voice for residents who may not feel they have one."

Gallipolis resident John Brewer feels he is giving back to the community when he volunteers his time in the Ombudsman Program. "I experience a lot of enjoyment and satisfaction through my time as a Volunteer Ombudsman," Brewer comments. "I am always welcomed with open arms by residents I come in contact with as they know I have their best interests at heart."

Lavon Shields of Jackson, who has served as a Volunteer Ombudsman for seven years, says volunteering gives her the "satisfaction that I have helped residents by serving as an advocate for them". She adds that the training provided by Agency staff provides volunteers with valuable knowledge that helps with providing this needed assistance. Shields encourages those individuals who have a love for people to consider becoming a Volunteer Ombudsman. "I enjoy every bit of it," she says.

"Volunteer Ombudsmen are invaluable to the AAA7 Ombudsman Program and the residents they serve," says Kaye Inoshita, RN, Director of AAA7's Ombudsman Program. "Through their wonderful service, volunteers provide a regular presence in our large ten-county service region while assisting with concerns regarding resident care."




Anyone who is 55 years of age or older and a resident of Ohio may participate. The Area Agency on Aging District 7, Inc. requests no more than three entries in the Art Show per participant, and no more than five entries in the Essay/Poetry Contest per participant. In addition, all Art Show entries must be suitable for wall display. Those who wish to indicate their work is for sale may do so. Art entries must be no larger than two feet by two and a half feet, including the frame.

Examples of art categories that may be entered in the Contest include acrylic, charcoal, counted cross stitch, mixed media, oil, pastels, pencil, and photography. Judging themes include abstract, animals and birds, cartoons, floral, landscape, portraits (humans), seascape, and still life.

Artwork can be submitted through your local Senior Citizens Center in the ten counties included in AAA7's District (Adams, Brown, Gallia, Highland, Jackson, Lawrence, Pike, Ross, Scioto and Vinton) up until Monday, May 3, 2010, or the AAA7 Office located on the campus of the University of Rio Grande by Monday, May 10, 2010.
